

**THE BOROUGH OF READING (CIVIL ENFORCEMENT AREA)
(WAITING RESTRICTIONS REVIEW 2023B)
ORDER 202***

The Reading Borough Council (hereinafter referred to as "The Council"), pursuant to its powers under Sections 1, 2, 3, 4, 32, 35, 45 and 46 to The Road Traffic Regulation Act 1984 (The Act of 1984) and Part IV of Schedule 9 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

PART I

CITATION

1. This Order shall come into operation on [●] and may be cited as "The Borough of Reading (Civil Enforcement Area) (Waiting Restrictions Review 2023B) Order 202*

INTERPRETATION

2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

"Ambulance"	has the same meaning as in the Vehicle Excise and Registration Act 1994;
" Authorised agent "	means an employee or agent of the Council authorised to exercise all or any of the functions of the Council under this Order;
"Blue badge"	has the same meaning as Disabled persons badge;
Blue Badge holder	means a vehicle specific permit issued by the Council to a disabled persons badge holder or any other person who resides in the same household as disabled persons badge holder, which permits the vehicle to be left in a disabled persons parking place in or at which a vehicle displaying a valid disabled persons badge may be left under the provisions of this Order, as an alternative to the display of a disabled persons badge;
"Civil Enforcement Officer"	has the same meaning as in section 76 of the Act of 2004;
"Disabled Person's Badge"	have the same meaning as in regulation 3 (1) of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 (as amended);
"Driver"	in relation to a vehicle waiting in a Parking Place or on a Road or length of Road, means the person driving the vehicle at the time it was left in that Parking Place or Road or length of Road;

"Goods"	means Goods or burden of any description and includes postal packets of any description;
"Goods Vehicle(s)"	means a Motor Vehicle which is constructed or adapted for use for the carriage of Goods or burden of any description and which does not exceed 5.30 metres in length or 2.25 metres in height;
"Hackney Carriage"	means a vehicle licensed under Section 37 of the Town Police Causes Act 1847, Section 6 of the Metropolitan Carriages Act 1869, or any similar enactment;
"Loading"	means the loading or unloading of Goods to or from a vehicle;
"Motorcycle" and "Invalid Carriage"	have the same meanings as in Section 136 of the Road Traffic Regulation Act of 1984;
"Motor Vehicle"	means a mechanically propelled vehicle, intended or adapted for use on Roads, and not being a Motorcycle;
"Owner"	in relation to a vehicle, has the same meaning as in Section 92(1) of the Traffic Management Act 2004 or the person who has the use of such a vehicle in the course of his/her employment and is entitled to use such a vehicle as though he/she were the registered keeper thereof;
"Parking Place"	means an area on the highway designated and authorised and identified as a Parking Place in the Schedules to this Order;
"Permit"	means a permit issued under the provisions of Part IV of this Order;
"Permit Holder"	means a person to whom a Permit has been issued;
"Red Route"	means the lengths of roads as specified in Schedule 3
"Relevant Position"	means in respect of: (a) a parking permit: (i) in the case of a vehicle fitted with a front windscreen, that the badge or permit is exhibited thereon with the front facing forward on the nearside of and immediately behind the windscreen; or (ii) the case of a vehicle not fitted with a front windscreen, that the badge or permit is exhibited on the front or nearside of the vehicle; (b) a Disabled Person's Badge, in accordance with Section 12 of The disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;
"Resident"	means a person whose usual place of abode is at premises the postal address of which is in a road or part of a road specified in Schedule 10;
"Residents Parking"	means a Permit issued by the Council to a Resident under the

Permit	provisions of this Order;
“Residents Parking Place”	means the length of a road specified in Schedules 5, 7, 8, and 9 of this Order for use as a Parking Place for a vehicle which displays in the Relevant Position a Residents Parking Permit;
“Road(s)”	has the same meaning as in Section 142(1) of the Road Traffic Regulation Act 1984;
“Shared Use Parking Space”	means a part of the Road identified as such within Schedules 5 and 8 for use as a Parking Place;
“Specific Class”	means a passenger vehicle, a Goods vehicle, or an Invalid Carriage;
“Specified Position”	a vehicle left in a Parking Place during the permitted hours in accordance with the foregoing provisions of this Order shall cause it so to stand so that every part of a vehicle is within the limits of a Parking Place;
“Virtual Permit”	means an electronic record of a parking permit that has been registered to a vehicle through the Council’s online virtual parking permit system.

- (a) The Interpretation Act 1978 (as amended) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament;
- (b) Any reference in this order to any Enactment or regulations made thereunder shall be construed as a reference to that Enactment as amended by any subsequent Enactment or regulations.
- (c) Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order;
- (d) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail;
- (e) Nothing in this order shall prevent the Council from suspending any of the restrictions within this order.

**PART II
PROHIBITIONS AND RESTRICTIONS**

4. WAITING AND LOADING OF VEHICLES

Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle:

- i. to wait at any time, on any day in the length of roads set out in Schedule 4 of this Order.
- ii. to wait, load or unload at any time, on any day on the length of roads set out in Schedule 1 of this Order.
- iii. to wait for a period exceeding 1 hour, with no return within 1 hour, from Monday to Saturday inclusive between 8am to 6.30pm in the length of roads set out in Schedule 6 of this Order.
- iv. to load for a period exceeding 40 minutes at any time, on any day on the length of roads set out in Schedule 2 of this Order.

4.1 RED ROUTE NO STOPPING

Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle to stop at any time, on any day in the length of roads set out in Schedule 3 of this Order and the length of road shall be used for loading only for a period not exceeding 40 minutes on any day from 9.30am to 4pm and from 6pm to 11pm.

PART III

GENERAL EXEMPTIONS

5. Nothing in Article 4 shall render it unlawful to any vehicle waiting, loading or unloading in the lengths of Roads specified in the schedules therein for so long as it may be necessary to enable:-
 - (a) a person to board or alight from the vehicle.
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other Road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations
 - (ii) the removal of any obstruction to traffic
 - (iii) the maintenance, improvement or reconstruction of the said lengths of Roads
 - (iv) the laying, erection, alteration or repair in or in land adjacent to the said lengths of Roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications system
 - (v) the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties.
 - (c) the vehicle to be used for the purpose of providing a postal service as defined in section 27 Postal Services Act 2011.

- (d) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said lengths of Roads.
- (e) the vehicle being used for fire brigade, ambulance or police purposes.
- (f) the vehicle is waiting while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise.
- (g) to a Disabled Person's Vehicle, displaying a Disabled Person's Badge in accordance with Section 12 of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 provided that such exemptions do not apply during the hours when waiting or loading restrictions are imposed by that Article.
- (h) to any vehicle, waiting upon an authorised Parking Place; or waiting for so long as may be necessary to enable the vehicle to be used in the provision of a local service within the meaning of the Transport Act 1985.
- (i) the vehicle has obtained permission from the Council by means of a dispensation to be displayed in the front or nearside of the vehicle and which includes information to enable the driver to be contacted in an emergency and providing the vehicle is not causing an obstruction by doing so, and that the vehicle can be moved if the driver is requested to do so by a police constable in uniform.
- (j) to enable the vehicle to access any premises situated on or adjacent to the said lengths of sides of Road so long as the waiting by that vehicle is reasonably necessary in connection with any wedding or funeral or other religious observances.
- (k) Nothing in Articles 4 (i) and (iv) shall prohibit any person from causing or permitting any vehicle to wait in the lengths of Road referred to therein for so long as may be necessary to enable Goods to be loaded or unloaded on/off that vehicle except for any period indicated when loading and unloading are not permitted in that length of the Road.

6. Nothing in Article 4 shall render it unlawful to any vehicle to stop in the lengths of Roads specified in Schedule 3 therein if:

- (a) required by law to cause the vehicle to stop or not to proceed
- (b) obliged to stop the vehicle so as to avoid an accident
- (c) prevented from proceeding in the vehicle by circumstances beyond the person's control
- (d) getting or giving help in consequence of an accident or an emergency, or otherwise taking action for public safety
- (e) opening or closing a gate or other barrier at the entrance to premises to which the vehicle is being driven or from which it has emerged if it is not reasonably practicable to cause the vehicle to stop elsewhere for the purpose
- (f) the vehicle is has stopped for the purposes specified in Article 5 (b), (e), (i) and (j).

PART III
AUTHORISATION AND USE OF PARKING PLACES

7. (1) Each area on a Road comprising, unless otherwise described the length of carriageway of a Road specified in Schedules 5, 7, 8, 9 bounded on one side of that length by the edge of the carriageway is authorised as a parking place.
- (2) Where in the lengths of Roads specified in the Schedules of this Order are authorised to be used as a Residents Parking Place then subject to the provisions of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle to park in the Residents Parking Place during its specified hours of operation unless it is a vehicle displaying in the Relevant Position a valid Residents Parking Permit issued by the Council.
- (3) Where in the lengths of Roads specified in Schedules 5 of this Order are authorised as a Shared Use Parking Space no person shall, except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle to park in the Shared Use Parking Space on any day, from 8am to 8pm for a period exceeding 2hrs, with no return within 2hrs unless the vehicle is a valid Permit Holder.
- (4) Where in the lengths of Roads specified in Schedule 8 of this Order are authorised as a Shared Use Parking Space no person shall, except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle to park in the Shared Use Parking Space on any day, from 8am to 8pm for a period exceeding 2hrs, with no return within 2hrs unless the vehicle is the valid Permit Holder of Zone B2/15R.
- (5) Where in the lengths of Roads specified in Schedules 7 of this Order are authorised to be used by Blue Badge holders only, no person shall, except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle to park in that length of road at any time, on any day unless it is a vehicle displaying a Blue Badge in the Relevant Position.
- (6) Where in the lengths of Roads specified in Schedules 9 of this Order are authorised to be used by Resident Permit Holders only Past this Point (ZONE 01R) no person shall, except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle to park in that length of road at any time, on any day unless it is a vehicle displaying a Resident Permit Holder of Zone 01R in the Relevant Position.
8. Where in the Schedules a Parking Place is described as available for vehicles of a Specific Class or in a Specified Position, the Driver of a vehicle shall not permit it to wait in the Parking Place unless it: -
- (a) is of the Specified Class; or as the case may be
- (b) is in the Specified Position
- (c) hold a valid parking permit issued by the Council.
9. A Driver of a vehicle shall not use a Parking Place:-
- (a) so as to unreasonably prevent access to any premises adjoining the Road, or the

use of the Road by any other person, or so as to be a nuisance

- (b) when a Police Constable in uniform, a Civil Enforcement Officer or a or a person authorised by the Council has closed the Parking Place
 - (c) specified in Article 7 during the periods specified in these Article unless the vehicle is displaying a valid permit in the relevant position and that permit is displayed during the whole time that the vehicle remains in the Parking Place.
10. The Driver of a Motor Vehicle using a Parking Place shall stop the engine as soon as the vehicle is in position in the Parking Place and shall not start the engine except when about to change the position of the vehicle in, or to depart from, that Parking Place.
 11. No person shall use a vehicle whilst it is in a Parking Place in connection with the sale of any article to persons in or near the Parking Place, or in connection with the selling or offering for hire of his skill or services.
 12. When a vehicle is left in a Parking Place in contravention of the provisions of Article 7, a Police Constable in uniform, or a parking attendant or a person authorised by the Council to do so may alter or cause to be altered the position of the vehicle so that its position shall comply with that provision.
 13. Any person altering the position of a vehicle by virtue of Article 7 may do so in such manner as he thinks necessary.
 14. A Police Constable in uniform, or a Civil Enforcement Officer or a person authorised by the Council to do so may, in case of emergency, or in contravention of Article 7, remove or cause to be removed to any place he thinks fit any vehicle left in a Parking Place.
 15. Any person removing or causing to be removed a vehicle from a Parking Place in accordance with Article 7 shall provide for the safe custody of the vehicle.
 16. Nothing in Articles 7 to 15 shall prevent a person from parking a Motorcycle in a Residents Parking Place as detailed in Schedules 5, 8 and 9 of this Order.
 17. Nothing in Articles 7 (1) to (6) shall prohibit any persons from causing or permitting any vehicle to wait in a Parking Place for so long as may be necessary for the purposes specified in Article 5 (a) to (j).

PART IV **PERMITS**

18. (1) Any Resident, who is the Owner of a vehicle of the Specified Class may apply to the Council or an Authorised Agent for a permit for the parking of that vehicle in a Parking Place and any such application shall be made on a form issued by and obtainable from the Council or Authorised Agent and shall include the particulars and information required by such form to be supplied.
- (2) Any Resident, who is the Owner of a vehicle of the Specified Class may apply for a virtual parking permit by registering online and make their application using the Council's virtual parking permit system, submitting such information as may be required to enable the Council to confirm the validity of the application AND the Council, having received an application and being satisfied that the applicant meets the necessary requirements and following receipt of full payment shall issue to the applicant the virtual permit applied for.

- (3) The Council or Authorised Agent may at any time require an applicant for a Permit or a Permit Holder to produce to an officer of the Council or Authorised Agent such evidence in respect of an application for a permit as they may reasonably require to verify the particulars or information given to them or to verify that the permit is valid.
 - (4) The Council or Authorised Agent upon being satisfied that the applicant is:-
 - (a) a Resident who is the Owner of a vehicle of the Specified Class, shall issue to the applicant a Residents Parking Permit for the leaving during the permitted hours in a Parking Place of the vehicle to which such permit relates, by the Owner or by any person using such vehicle with the consent of the Owner (other than a person to whom such vehicle has been let for hire and reward);
 - (5) A Resident shall not be entitled to be in possession of more than one permit at any one occasion.
 - (6) A Residents Parking Permit shall only be a valid for use in a Parking Place specified in Schedules 5, 8 and 9.
- 19.** Notwithstanding the provisions contained in this Order the Council may also grant permits to such other persons as they may think fit.
- 20.**
- (1) A Permit Holder may surrender such permit to the Council or Authorised Agent at any time and shall surrender such permit to the Council or Authorised Agent on the occurrence of any one of the events set out in paragraph (3) of this Article.
 - (2) The Council or Authorised Agent may, by notice in writing served on the permit holder at the address shown by that person on the application for the permit or at any other address believed to be that person's residence, withdraw a permit if it appears to the Council or Authorised Agent that any one of the events set out in paragraph (3) of this Article has occurred and the Permit Holder shall surrender the permit to the Council or Authorised Agent within 48 hours of the receipt of the aforementioned notice.
 - (3) The events referred to in the foregoing provisions of this Article are:-
 - (a) the permit holder ceasing to be a resident;
 - (b) the permit holder ceasing to be the Owner of the vehicle in respect of which the permit was issued;
 - (c) the vehicle in respect of which such permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 18(1);
 - (d) the issue of a duplicate permit by the Council under the provisions of Article 19;
 - (e) the expiry of the period for which the permit was issued;
 - (f) where a permit is issued to any person upon receipt of a cheque and the cheque is subsequently dishonoured, the permit shall cease to be of any effect;

21. Without prejudice to the provisions of this Order, a permit shall cease to be valid at the expiration of the period specified thereon:-
- (a) which period, in the case of a Residents Permit, shall not exceed a period of twenty-three months from the end of the month during which it first became valid;
- or on the occurrence of any one of the events set out in paragraph (3) of Article 20, whichever is the earlier.
22. (1) If a permit is accidentally mutilated or defaced or the figures or particulars thereon have become illegible or the colour of the permit has become altered by fading or otherwise, the permit holder shall surrender it to the Council or Authorised Agent and apply to the Council or Authorised Agent for the issue to him of a duplicate permit, whereupon Council or Authorised Agent, shall issue a duplicate permit so marked and upon such issue the original permit shall become invalid.
- (2) If a permit is lost or destroyed, the permit holder may apply to the Council or Authorised Agent for the issue to him of a duplicate permit and the Council or Authorised Agent upon being satisfied as to such loss or destruction, shall issue a duplicate permit so marked and upon such issue the permit shall become invalid.
- (3) All the provisions of this Order shall apply to a duplicate permit to the same extent as they applied to the original permit.
23. A permit shall be in writing and shall include the following particulars:-
- (a) the registration mark of the vehicle in respect of which the permit has been issued;
- (b) the period during which, subject to the provisions of the preceding Articles, the permit shall remain valid;
- (c) an authentication that the permit has been issued by the Council;
- (d) a code indicating the parking area for which the permit is valid.
24. At all times during which a vehicle is left in a Parking Place specified in the Schedules during the permitted hours, there shall be displayed in the Relevant Position a permit issued in respect of that vehicle valid for Parking Place.
25. When a permit has been displayed in accordance with the provisions of Article 24, or where a penalty charge notice has been attached to the vehicle, no person other than a Police Constable in uniform, Civil Enforcement Officer or a parking attendant shall remove such permit or notice from the vehicle unless authorised to do so by the driver of that vehicle.
26. Notwithstanding the foregoing provisions of this Order, the Council may at its discretion issue a discretionary notice allowing a specific vehicle to wait in a Road or a Parking Place during the hours of operation of any restriction or prohibition to the contrary.

PROVISIONS RELATING TO VIRTUAL PARKING PERMITS

27. A Virtual Parking Permit may be obtained by any of the methods provided from time to time by the Council and to be valid must be registered on an account in an electronic

database approved by the Council and an indication that payment has been made and the parking period for which payment has been made shall either;

- a) appear on a hand-held device; or
- b) be obtained by a Civil Enforcement Officer contacting the service provider.

- 28.** If at any time while a vehicle is left in a parking place, there is no indication as set out in Article 27 that payment of the charge for a Parking Permit has been made using the Virtual Parking Permit system, or there is an indication that the parking period for which payment was made has expired, it shall be presumed, unless the contrary is proved, that either;
- (a) the charge for the Parking Permit has not been duly paid in respect of that vehicle;
or
 - (b) the parking period for which payment was made had already expired.
- 29.** Where a Virtual Parking Permit has been obtained as an alternative to a Parking Permit and remains valid, any requirement for the Parking Permit to be displayed on the vehicle to which it relates shall not apply.
